

# Privacy Policy

This Privacy Policy ("Policy") applies to <https://clarityaba.com/>, and Clarity ABA ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include <https://clarityaba.com/>. The Company's website is a informational site. By using the Company website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
- Mailing address
- Email address
- Phone number
- Any information you choose to share when requesting information about services or careers.
